REVISED ADMISSION NOTIFICATION

Pursuant upon the resolution of the Gauhati University Admission Committee meeting held on 14/05/2022, this is for the information of all concerned that the eligibility criteria and timeline for admission into MBA Programme of Gauhati University for the session 2022-23 have been revised as follows:

1. Revised Eligibility Criteria:

- a) A Bachelor's Degree in any discipline with 50% marks (Relaxation up to 5% in the qualifying marks shall be allowed to the candidates belonging to the reserved categories) in aggregate or in Honours/Major subject (if any) from Gauhati University or any other recognized University.
- b) **Candidates who will be appearing in the final semester examination of the qualifying bachelor's degree are eligible to appear and if selected must meet the eligibility criteria of the MBA Programme in due course of time.**

2. Revised Timeline:

- a) Re-opening of Online Application Form : **May 14, 2022**
- b) Last date of Online submission of Application Forms : **May 30, 2022**
- c) Admit Card available online : **June 4, 2022 onwards**
- d) Written Test : **June 12, 2022**

- 3. Revised last date for submission of Other Category Forms (only applicable for applicants who applied under the category of Differently Abled ,Son/Daughter of permanent G.U. Employees in service, Son/Daughter of G.U. Ex-Employees, Son/Daughter of Ex-Defence Personnel, Fringe Village, Extra-curricular Activities and NCC/NSS) : **May 30, 2022****
